



## MEMORANDUM OF UNDERSTANDING

#### between

# Novosibirsk State Technical University, Russia, and SASTRA Deemed University, India

Novosibirsk State Technical University having its registered office at 20 Prospekt Karla Marksa, Novosibirsk, 630073, Russia (hereinafter referred to as "NSTU") and SASTRA Deemed University having its registered office at Tirumalaisamudram, Thanjavur – 613 401, Tamil Nadu, India (hereinafter referred to as "SASTRA") to strengthen and facilitate mutual academic exchanges, enter into this agreement with the aim to share, collaborate, and develop the existing foundations of each institution. This agreement shall be effective from the date the agreement is signed by both institutions.

Both institutions agree to the following:

#### 1. Field of cooperation

Both institutions focus their cooperation on Computer Engineering, Software and Automation field.

Both institutions, represented by the NSTU Faculty of Automation and Computer Engineering and SASTRA School of Computing shall be open for engaging in the following types of cooperation:

- Exchange of students
- · Exchange of faculty and staff
- Exchange of academic materials
- Joint research projects and educational programs
- · Sharing of scientific materials, publications, and information
- · Dual degree programs
- Collaborative professional development
- Other activities as specified or mutually agreed upon designed to strengthen cooperation

#### 2. Additional Agreements

To facilitate and maintain the efficiency and effectiveness of cooperation, both institutions shall make separate detailed agreements (especially for exchange and specific programs). These agreements shall include key details relating to obligations made by each institution, and shall not be put into effect until they have been reviewed and approved by authorized representatives. Such agreements shall specify the personnel involved, duration of the program or project, academic credits, and source(s) of funding, if required.

## 3. Equal Opportunities

Both institutions agree to the policy that, in accordance to laws, codes, and guidelines, no person shall be discriminated against in regard to age, skin color, disability, nationality, race, religion or gender. Anything not related to a student's performance, aptitude or credentials should not be a deciding factor in their application.

# 4. Promotional Material & Advertising

An institution's logo or name shall not be used by the other institution without prior written consent, and in accordance with the institution's internal policies.

# 5. Assessment Period

- All programs, projects or ventures undertaken by NSTU Faculty of Automation and Computer Engineering and SASTRA School of Computing shall be subject to agreed periodic assessments and evaluations by appropriate representatives of the programs or projects involved.
- The agreement signed by both institutions shall remain effective for five (5) years. The agreement may be terminated if each institution mutually agrees, but there must be at least a six (6) month advanced notice before the intended termination date.
- The agreement can be amended or renewed by written consent, and must be signed by authorized representatives of each institution.
